Terms and Conditions of use

The use of this website of the Central Bank of Chile (hereinafter the "Bank") shall be governed by the terms and conditions set forth below. To use the Web Services (hereinafter "API-Web Services") provided through this Website, (hereinafter the "Website") you must be registered as a user (hereinafter the "User") and accept the Terms and Conditions of Use of this site (hereinafter the "Terms and Conditions ") and the information contained herein, as well as any modification to them made by the Bank, at any time.

The sole purpose of API-Web Services is to facilitate the capture and use of the statistics published by the Bank, by making available a direct and standard transmission service between information systems, of data and series obtained directly from the Statistics Database published by the Bank on its official website (hereinafter the "Information"). Therefore, the User may also directly consult, download and use the statistical data contained in the Statistics Database, as well as those in Excel and PDF formats, in the Statistics section of the Bank's website. The registered User will be provided with an account with which User will be able to access the statistical series available in the list contained on the Website. The User will be able to review the list and select the series required.

The User may consult, reproduce, disseminate, publish or adapt the information contained on the Website, always mentioning that it is the property of the Central Bank of Chile. In the case of adaptations (derived data) that may be published or disseminated by the User, it must be stated that the source information belongs to the Bank or whoever is responsible for it and that the adaptation is the property and exclusive responsibility of the User.

The Bank makes available to the User a free software or application, as well as Python and R codes, which allow the use of the API-Web Services, with no technical support responsibility for the Bank. Both the software and the functions in Python and R can be downloaded and used voluntarily by the User, however, it will be the sole responsibility of the User to create their own programs or use those provided by the Bank in their computer systems, making the necessary adjustments and installations for the proper functioning of the API-Web Services. It is hereby stated for the record that Central Bank of Chile assumes no responsibility whatsoever, nor does it grant any kind of guarantee with respect to the software and functions for the use or application made thereof, and the User may not commercialize them and must use them exclusively for the purpose for which they were created.

The rights of use of the information contained in the Website, described above, are granted indefinitely and at no cost to the User, and the Bank reserves the right, under its sole discretion, to modify, add, limit or revoke such rights, the structure, presentation and contents thereof, as well as to deny access to users, companies or organizations that breach the provisions of the governing Terms of Conditions , which will be determined by the Bank under its sole discretion.

The User may use the maximum number of series presented in the series list. In terms of frequency of queries, the User shall only request a maximum of 5 (five) simultaneous series per second (corresponding to five queries to the API-Web Services), per enabled account, regardless of the IP address from which the queries are made. In case of non-compliance by the user, the Bank reserves the right to suspend the API-Web Services temporarily or indefinitely.

The rights of use set forth in the Terms of Conditions are limited to the information and frequency of use indicated by the User in the User Registration Form which forms part for all legal purposes of the Terms of Conditions.

The User agrees to use the Website and the information contained therein under User entire and exclusive responsibility, expressly declaring to know and accept that the Bank is not responsible nor assumes any obligation whatsoever for losses, damages, expenses or any other harm that may have their origin or cause due to the access to the Website or to the information contained therein, releasing the Central Bank of Chile from any liability for direct, indirect, foreseen and unforeseen, present or future damages, or of any kind that the user may experience due to the information and API-Web Services provided or that may be caused by these concepts. Therefore, before proceeding to the use or application of the information existing in the Website, in any type of acts, contracts, business and operations, the user must verify with the official sources of the data whose source is not the Central Bank of Chile.

The Central Bank of Chile shall not be liable for damages caused or that may be caused to the User by failures or interruptions of API-Web Services, whatever their cause or source.

The User accepts that he shall be solely responsible for the use of the password provided by the Central Bank of Chile to use the API-Web Services, and the Central Bank of Chile shall not be held liable for any misuse or fraudulent use of the password.

The User is obligated to indemnify, defend and hold harmless the Central Bank of Chile for any type of damage, whether direct or indirect, as well as any sort of complaint, legal action or lawsuit that could affect the Central Bank of Chile, including but not limited to any expenses incurred for legal or other services deriving directly or indirectly from the use of the API-Web Services or the content of the Website or from noncompliance with the Terms of Conditions. Any dispute, claim or disagreement arising out of or in connection with the Terms and Conditions, including the access, use or application of this website or of the information contained herein shall be referred to, and resolved in accordance with the laws of the Republic of Chile and the jurisdiction of the Chilean courts.
